ANTI RAGGING COMMITTEE

"RAGGING LEADS TO TEARS, SHAME, TERROR AND SOMETIMES DEATH"

RAGGING:

Ragging is any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness to any student indulging in rowdy or undisciplined activities which cause or likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the psyche of a fresher or a junior student."

-Honourable Supreme Court of India.

'Nursing' is a noble profession. Its members are revered for their human values, compassion and consideration for their fellow human beings. Every nursing student shall therefore learn to be self-disciplined and observe rules and regulations as a matter of habit rather than because of fear of consequences. They shall at all times conduct themselves with proper dignity and decorum expected of a budding nurse. The following instructions are framed to prevent the menace of ragging and foster healthy interpersonal relations among students at "federal college of nursing".

INC REGULATIONS ON RAGGING

Indian Nursing Council (INC) has made it very clear that all INC approved institutions should strictly follow the directions of Hon'ble Supreme Court of India and Committee recommendations without exception. It is clearly mentioned in the regulation that RAGGING is totally banned and anyone found guilty of ragging and /or abetting ragging is liable to be punished.

OBJECTIVES:

1. Ensure ragging free campus and college.
2. For fulfilling organizational missions and objectives, by maintaining free of ragging, prohibit, prevent and eliminate the source of ragging.
3. Maintain amicable relations among students and faculty.
4. Punishing those who indulge in ragging.

FUNCTIONS OF COMMITTEE:

1. To maintain documentation regarding the Anti-ragging committee members.
2. To keep / maintain the Federal College of Nursing anti ragging free.
3. To keep in touch with the students to identify any incidents of ragging.
4. To clarify / investigate about the incident.
5. If found guilty, first warn, and in subsequent incidents take strong actions like punishments and fines.
6. Report the incident to the higher Authorities for further management.
7. To keep vigilance / check regularly to stop/ avoid ragging among students.

Instructions to students:

1. Ragging is strictly forbidden in or outside the campus.
2. All students shall familiarize themselves with rules/regulations/guidelines on code of conduct, anti-ragging measures and discipline of the institute.
3. Any student who suffers ragging or notices occurrence of ragging shall immediately report the event to concerned authority.
4. Incidences of ragging can be reported to any member of anti-ragging squad, Anti-ragging committee of the college.
5. Students may report incidence of ragging either orally or in writing. They may also report the incidence in person or by phone. Anonymity of the caller will be maintained.
6. The college council has identified some senior students as 'Member'. List of these students is placed on all notice boards of the college. A fresher may choose any one of them as his buddy. He/she will provide emotional and peer support to the fresher in coping with institutional transition.

Following type of abuses and activities will be termed as ragging:

- Physical abuse: for example, forcing to eat, drink or smoke, forcing to dress or undress.
- Verbal abuse: for example bad words and phrases, direct or indirect offensive references to the person's appearance, attire, religion, caste, family or chosen field of study.
- Lifestyle restrictions: for example, Enforcing rules regarding shaving or oiling hair.
Forcing certain kinds of dress
Restricting access to parts of the hostel e.g. common room.
Requiring certain modes of address i.e senior should be called sir or Madam
Requiring a particular wake-up time announced by the senior.

- **Forced Activity :** For Example

- Chores for senior e.g. cleaning rooms etc.
- Missing Classes, Not being allowed to study.
- Staying Awake late or getting up at unreasonable times.
- Singing or Dancing or performing in any other way.
- Using foul language or shouting or cheering loudly.
- Misbehaving with strangers, particularly women.

RULES AND REGULATION :

Administrative action in the event of ragging.


- Suspension from attending classes and academic privileges.
- Withholding /withdrawing scholarship / fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/ Expulsion from the hostel.
- Cancellation of admission.
- Rustication from the institution for period ranging from one to two years.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
- Filing FIR with the police.
- According to the relevant section of the Indian penal code IPC those found guilty of ragging related offence can be punished with imprisonment or fine or both. The Quantum of the punishment varies with the gravity of the crime. for example , section 323 which deals with the cases of voluntarily causing hurt, can lead to imprisonment up to 1 year or fine or both , section 306 which deals with abetment to suicide ,Specifies the punishment as imprisonment up to 10 year with or without fine.
